The ARRIVE Essential 10

These items are the basic minimum to include in a manuscript. Without this information, readers and reviewers cannot assess the reliability of the findings.

Inclusion and exclusion criteria	3 a. Describe any criteria used for including and excluding animals (or experimental units) during the experiment, and data points during the analysis. Declaration of interests	21 a. Declare any potential conflicts of interest, including financial and non-financial. If none exist, this should be stated. b.
