These items are the basic minimum to include in a manuscript. Without this information, readers and reviewers cannot assess the reliability of the findings.

Study design	1 For each experiment, provide brief details of study design including: <ol style="list-style-type: none"> The groups being compared, including control groups. If no control group has been used, the rationale should be stated. The experimental unit (e.g. a single animal, litter, or cage of animals). 	182-190
Sample size	2 <ol style="list-style-type: none"> Specify the exact number of experimental units allocated to each group, and the total number in each experiment.
